PRESIDENT'S REPORT

2023

- Resurfaced the tennis courts and added two pickleball courts
- Added handicap access to swimming pools
- Completed replacement of bulkhead a lake
- Stained perimeter fencing on Newport Boulevard
- Replaced stone wall with fence at Patio Woods entrance
- Removed numerous trees due to drought and 2023 winter freeze
- Upgraded software to allow owners to view their accounts. This conversion should take place in late December and should be available for owners to view their accounts by the end of the first quarter, once all information has been verified and kinks worked out.

Work that was approved in 2023 to be completed as soon as weather permits:

- Resurfacing of the parking lots at Stonebridge and HOA Management office
- We are still waiting on Centerpointe to approve a location for a pole to install landscape lighting and irrigation for South Diamondhead.

2024

- The main capital improvement for 2024 is to re-do the entrances on North and South Diamondhead and Newport Boulevard.
- Replace trees in common areas
